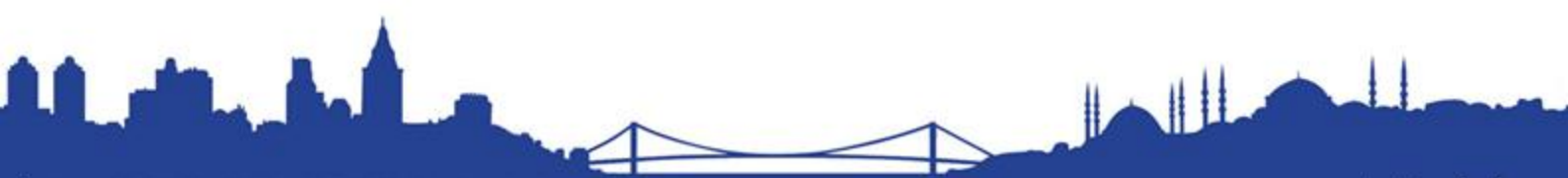

## **ONE BELT ONE ROAD (10:15 – 11:15) (ROOM A)**

One Belt One Road (OBOR) is an investment project which was announced in 2013 by Chinese President Shi Jinping, involving a population of 3 billion in a unique market. The OBOR project which will totally change the future of the global economy and even politics will shape the next 50 years with its structure including Turkey. The project, which has a population of 1 trillion dollars and has a population of more than 3 billion, contains 65 countries. By 2030, a McKinsey Report suggest, over 15% of the current workforce will no longer exist.
