





The two largest and most important medical cannabis events return to Medellin: EXPOMEDEWEED and CANNAWORLD CONGRESS 2019

The international **EXPOMEDEWEED 2019** fair will be held between November 22 and 24 in the Orquideorama and in the Patio de Las Azaleas of the Joaquín Antonio Uribe Botanical Garden; It will be a high level event, with the professionalism, positioning and experience that have taken it to the fourth version.

EXPOMEDEWEED is a specialized cannabis business platform, where companies in the industry will meet to showcase their products, transfer technology and knowledge, discuss their developments and research, close sales, propose projects and offer the best executive environment for exploit all the medicinal, industrial and scientific potential of cannabis.

In the Restrepo room, the already recognized academic talks will be held to which the attending public who acquired a ticket to enter **EXPOMEDEWEED** may have access free of charge, with prior registration, given that quotas are limited.

Business conference, prelude to EXPOMEDEWEED 2019

In this event you can have access to indexed memories, that is, books, book chapters, among others, as a result of the different investigations, as well as the standards of the National Department of Science and Technology - COLCIENCIAS, with the appropriate controls bibliographic and copyright to guarantee the creation of spaces for communication and exchange of knowledge, knowledge and culture among actors interested in medical cannabis and to open the dissertation on the medicinal, industrial, scientific and business potential of cannabis.

The academy at EXPOMEDEWEED and CANNAWORLD CONGRESS 2019, focused on 4 axes

The central theme defined for this year, which will be the navigation route for conferences and talks, is "the industrial and research development of the production and use of medical cannabis." The thematic axes are defined as follows:

- Axis 1: Development of products and / or processes:







Research or work (completed or with preliminary results) framed in the development of products or processes at any stage of the production chain of medicinal cannabis derivatives such as: seed, cultivation, manufacture, distribution (import and / or export); Likewise, the use of industrial cannabis derivatives emphasizing innovation.

- Axis 2: Development of health research:

Research or work (completed or with preliminary results) related to the use of medicinal cannabis derivatives in the treatment of patients with neurodegenerative diseases; behavioral, eating and mood disorders; autoimmune diseases such as cancer, HIV AIDS and / or orphan diseases, as well as the treatment of patients with symptoms of chronic pain, lack of appetite, among others.

- Axis 3: Development and research in social and cultural processes:

Research or work (completed or with preliminary results) related to direct actions to social groups that favor cultural development around the use and production of medical cannabis, impacting the re-significance of medical cannabis and the quality of life of people who produce and / or use (training and training workshops, focus groups, experiences with communities, among others).

- Axis 4: Development in legislation and research:

Approach to the correct reading and interpretation of the regulations established for the production, use and research of medical cannabis in Colombia.

The call for researchers will be open until October 31 of this year and soon the website for the presentation of the works will be published on the website www.cannaworld congress.com.
